- Min 001/21 **Apologies for Absence**. Apologies for absence were received and accepted from Cllrs Wiseman (internet connection problem) and Naughnane (work commitments).
- Min 002/21 **Declarations of Interest.** There were no declarations of interest
- Min 003/21 Minutes of Meeting Held on Tuesday 8 December Cllr Greene proposed and Cllr Townshend seconded that the minutes be signed as a true record of the meeting. It was unanimously AGREED that the minutes of the meeting dated 8th December 2020 be duly authorised as a true record of that meeting. The minutes were signed by the chairman outside the meeting.
- Min 004/21 **Co-option to Fill a Vacancy.** Members were asked to consider an application by Robert Scott, who has worked in the village for the required period, to be co-opted to the parish council. It was proposed by Cllr Mullenger and seconded by Cllr Greene that Robert Scott be co-opted to the parish council. This was **AGREED unanimously and Cllr Scott duly signed his Declaration of Acceptance of Office and joined the meeting.**
- Min 005/21 **County/District Councillor Reports.** Copies of the written reports had been circulated previously to members. These were noted by the council. A discussion about HGV traffic through the village took place and the clerk agreed to forward information about vehicles and routing by the police that he was aware of. The district councillor advised of the cessation of the joint working agreement that Breckland had with South Holland District Council and the possibilities for future joint working and governance in Norfolk.
- Min 006/21 **Bench on The Street.** The clerk reported that the application for the reinstatement of the bench had still not been approved by Norfolk County Council.Councillor Kiddle Morris advised that he had held a site visit with the new in post highways engineer and asked him to progress as a priority. The clerk confirmed that he had received a quotation of £350 to refurbish the recently removed bench from the village green to include replacement of all timber slats and the repainting of the metalwork and he had given the go-ahead for these works. The verbal reports were **NOTED**
- Min 007/21 Millenium Lakes. Correspondence re the future use of the area was considered by the council. It was AGREED that a site visit would be held to discuss ideas and the item would then formally be considered at the next meeting

The provision of the bin would be the parish council's responsibility and NCC would then fill the bin as needed. It was noted that the location is not on a gritting route which could count against it and the county councillor highlighted the increase in the number of bins across the county some years ago and the likely sites that would be considered positively. He agreed to raise the matter with NCC to see if a bin at this location would be possible. It was **AGREED to consider when a response from NCC had been received**
